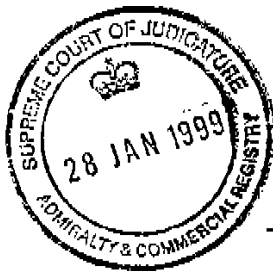

**JUDGMENT**

Mr Justice Timothy Walker having by Order dated 18th December 1998 ordered that the Applicant be at liberty to enforce the Award of Mr R.J. Short, Mr J.D. Allen and Mr F.M. Aldridge the Arbitrators appointed under the Arbitration Agreement dated on or around 10th July 1996 in the same manner as a Judgment or Order to the same effect.

And that the costs of the Application should be paid by FTC "Uzdon", Tashkent.

And the Arbitrators having by their Award dated 22nd August 1997 awarded that the Respondents do pay the Applicants the following:

- (a) US\$10,839,042.86.
- (b) £3,975.00.
- (c) Interest on the above sums, being \$1,244,856.65 and £456.53 respectively to date of Judgment and at 8% until date of payment.

It is this day adjudged the Respondents do pay to the Applicant the sums of US\$12,083,899.51 and £4,431.53 and the costs to be taxed.
